### **EXECUTIVE SUMMARY**

This is the semi-annual Social and Environmental Safeguards Monitoring Report (SMR) for the period July to December 2024, compiled by the Solomon Islands Water Authority for the Solomon Islands Urban Water Supply and Sanitation Sector Project (UWSSSP).

The aim of the project is to improve access to safe water and improved sanitation across the Solomon Islands focusing on five components: (i) Output 1: secure and safe urban water supplies; (ii) Output 2: effective, efficient and safe urban sanitation services; (iii) Output 3: enhanced awareness of good hygiene and water issues and sustained improved hygiene behaviour; (iv) Output 4: ensure SW is financially and technically sustainable, and (v) Output 5: Watershed protection – management of Honiara's watershed areas strengthened to build resilience to climate change.

This report describes the social and environmental safeguard activities undertaken during the period, with a focus on planning, pre-construction approvals, and construction/implementation. Whilst project outcomes have been delayed, implementation of environmental and social safeguards for UWSSSP projects continues to comply with both the country safeguards system and ADB/WB policies and instruments as set out in the Project's environmental assessment and review framework (EARF) and resettlement framework (RF).

All PERs required for UWSSSP Phase 1 have been completed and approved except the PER for Gizo water supply which is delayed awaiting approval for more hydrogeological investigations at Mile 6 lake and other surface water sources. The Honiara Water Main Replacement Subproject was finalized in this reporting period.. Comments from donors have been included in the final draft. External specialists reviewed and updated the PER in this reporting period. The updated version of the PER is expected to be submitted in Q1 2025 to donor partners for final review and no objection.

The proposal application for Auki project have been finalized and submitted to MECDM on 13<sup>th</sup> June 2024. No response from MECDM was received in this reporting period.

Monitoring of current UWSSSP phase 1 projects is ongoing during this reporting period. An environmental audit of all subprojects was carried out in this reporting period. Non-compliances were identified and communicated to contractors via site inspections report and site instructions. Generally, all sites were in compliance with Environmental conditions. Improvements in the use of MSDS and storage of hazardous materials were observed. Safe practices were observed across all sites.

For the Honiara Wastewater Project, land acquisition and resettlement plans (LARPs) are being prepared in sections covering western (National Referral Hospital (NRH)), eastern (Ranadi), and Ranadi Rd to Goodwood Outfall (a component of the eastern Ranadi section). For the western (NRH) section, currently the main concern is regarding a section of pipe which needs to be installed under land owned by the South Seas Evangelical Church (SSEC) who initially would not agree to the installation. However, they have now agreed. The MOU was signed on 4<sup>th</sup> April 2024.

There were seven (7) grievances registered during this reporting period. All of these grievances were resolved in this reporting period. The outstanding grievance at Kongulai to White river trunk main section was resolved during this reporting period.

Community Advisory Committees (CACs) have been established for Tasahe to Kongulai area, and the PMU is assisting contractors to establish a CAC for Titige and other sites. While SW is aware that it is important that the CAC are established before construction starts, this is proving a challenge, because in some commercial areas, where the majority of the properties are businesses and working people, there is no socially cohesive "community", and people do not want to join any committees. In the absence of an effective community structure, the CLO for SW is experiencing difficulties in establishing the CACs in the trunk mains sites of Panatina – Burns Creek, East Kola – Kukum, and White River – Town Ground.

### 1. INTRODUCTION

### Background

- 1. Solomon Islands has around 19.8% (or 102,030) of its estimated present total population of 669,823 (World Bank 2019)1 living in urban and peri-urban areas. The country is divided into nine provinces: Central, Choiseul, Guadalcanal, Isabel, Makira-Ulawa, Malaita, Rennell and Bellona, Temotu, and Western. The country's capital, Honiara City, is situated on the north-western coast of Guadalcanal. Malaita has the largest population of 160,583 people, followed by Guadalcanal (155,605), Western (98,820), Honiara city (90,441) and Central (32,603) based on the Solomon Islands National Statistics Office projected population by province.<sup>2</sup> The population growth rate is the highest in Guadalcanal (4.4%) followed by Honiara (2.7%), Western (2%), Central (1.9%) and Malaita (1.2%).3 According to the last available Household Income and Expenditure Survey, 12.7% of the population lived under the national basic needs poverty line in 2013 (9.1% in urban areas).
- 2. It is known that temporary and informal settlers are often not captured in the Census and at any one time the population of Guadalcanal can be closer to 200,000. Informal residential areas are characterized by uncertain or illegal land tenure, minimal or no access to public services (such as water supply, sanitation, electricity and roads) and a high presence of informal employment in the low income population. This presents challenges in providing potable water supply and sanitation services to the urban and peri-urban areas. To address the challenges, the Solomon Islands Water Authority Act of 1992 created the Solomon Islands Water Authority, trading as Solomon Water (SW), a state-owned enterprise, and mandated to provide for the proper management and development of urban water resources and wastewater services in Solomon Islands. SW has been guided by its Five-year Action Plan and 30-Year Strategic Plan since 2017. These plans outline the strategy to meet the demand for water and wastewater services up to 2047 for Honiara, including peri-urban areas, as well as meeting the needs of the provincial capitals and other major urban centres in Solomon Islands.

# **Project Description**

- The Urban Water Supply and Sanitation Sector Project (UWSSSP), in line with SW's plans, with funding from the Asian Development Bank (ADB), World Bank (WB), European Development Fund and the Solomon Islands Government (SIG), is implementing the Project to help improve access to safe water and improved sanitation. The UWSSSP outputs include: (i) Output 1: secure and safe urban water supplies; (ii) Output 2: effective, efficient and safe urban sanitation services; (iii) Output 3: enhanced awareness of hygiene and water issues and sustained improved hygiene behaviour; (iv) Output 4: ensure SW is financially and technically sustainable, and (v) Output 5: management of Honiara's watershed area strengthened to build resilience to climate change.
- 4. The UWSSSP has adopted a sector approach for developing sustainable. inclusive and climate resilient water supplies and improved sanitation, and for enhancing hygiene awareness, water conservation, and faecal sludge management. However, during early implementation it became apparent that some problems with

the water supply system are caused by lack of catchment protection, and in the context of the climate crisis, without watershed protection, the existing and future sources of water will not be reliable and will remain highly vulnerable to climate change. To be sustainable, output 5, the Honiara Watershed Management Project (HWMP) will focus on improving the management of watershed areas that are vital to a climate resilient water supply. The participatory-driven initiatives will include erosion and sedimentation control to reduce risks from flooding and landslides, and improvement of the ecosystem services provided by Honiara's catchment areas, including enhancement of water quality and regulation of water flow.

- Output 1 is intended to secure reliable and safe freshwater supplies by (i) increasing the number of urban households in Honiara with access to climate and disaster resilient water supplies; (ii) reducing non-revenue water from its 2017 level of 62% to 30% or less by 2027; and (iii) increasing SW water production capacity in Honiara by up to 5 million litres per day (ML/d) and improving SW water treatment capacity through the rehabilitation, replacement, or expansion of current sources and water treatment facilities, to meet water demand and ensure full compliance with drinking guidelines across the city by 2027. Investments will include: (a) in Honiara, (i) rehabilitation of existing water supply sources, and expansion of production and treatment systems, (ii) installation of water supply mains to expand and rehabilitate the water supply system, (iv) additional water storage capacity, (v) leak detection and pipeline repairs, (vi) installing bulk supply metering and expansion of SW's customer meter replacement program to install pre-payment meters, and (vii) expanding SW's water supply networks to an additional 5,700 connections in unserved areas, including in informal settlements; (b) in Auki, Gizo, Noro and Tulagi, rehabilitation and expansion of the existing water supply systems; and (c) in Munda, development of a new water supply system.
- 6. **Output 2** is intended for effective and efficient sewerage services by: (i) preparing septime management regulations, (ii) constructing a septage treatment facility under a five-year design-build-operate (DBO) contract to service the greater Honiara area, (iii) replacing existing wastewater outfalls in a state of disrepair with new ones, (iv) installing sewer mains to expand and rehabilitate the Honiara trunk sewer system, and (v) construction of new sewage pumping stations and rehabilitation of existing ones.
- 7. **Output 3** is intended to develop enhanced awareness of hygiene and water issues and sustained improved hygiene behaviour. This includes a hygiene awareness and promotion program to complement other ongoing hygiene awareness and promotion activities in urban areas.
- 8. **Output 4** involves implementing a program to assist SW strengthen its financial, technical, and operational sustainability. This includes developing policies, asset planning, data management, financial and technical systems monitoring, and reporting.
- 9. **Output 5,** the HWMP, involves: (i) strengthening capacity for planning (watershed data, mapping, hydrological modelling, and information sharing) ;(ii) empowering communities to implement solutions for effective management protection, and restoration of the forest and riparian habitats through partnerships; and (iii) facilitating interagency and inter-sectoral coordination and governance to develop long-term integrated catchment plans.

### 1.3. Purpose of this Report

- 10. The SMR is a requirement under the ADB Safeguard Policy Statement 2009 (SPS), WB policies and instruments (formerly Operational Policies and Bank Policies OP/BP 4.01, 4.04, 4.0, and 4.12 but since 2018, replaced by WB Environmental and Social Framework), and the project/loan agreements. The safeguards categories for this project are B for environment and B for involuntary resettlement.
- 11. This SMR covering the period from July to December 2024 and presents the undertakings during the reporting period, of both the social and environmental safeguards supporting the UWSSSP outputs as outlined above.

### 2. PROJECT PROGRESS

### 2.1. Project Overview

- 12. Implementation of environmental and social safeguards for UWSSSP projects continues to comply with both the country safeguards system and ADB/WB policies and instruments as set out in the Project's environmental assessment and review framework (EARF) and resettlement framework (RF).
- As always, uncertainties over land ownership (and occasionally, delays on the final selection of engineering design alternatives, which are essential to ascertain the affected persons) initially meant that safeguards staff often could not initiate community consultations over land tenure until designs were finalised. Most designs were finalised, but delays still continued in sites where, landowners (LOs) were reluctant to agree to some plans affecting their lands. Delays in producing Land Acquisition and Resettlement Plans (LARPs) were particularly pronounced in Honiara, where many people are reluctant to sell or lease land at current valuations, but have also affected the provincial water supply subprojects. At Noro, discussion with land claimants have progressed positively with commencement of works now agreed. Two consultations were held with the land owning groups in Honiara and Noro, with all generally in support of the project. Possession of the site was given as of 15 July, and the contractor (CCB Envico Pty Ltd of West Melbourne), is aimed for site mobilisation in October. Meanwhile the social safeguards team is continuing to work with LOs to resolve outstanding issues, and await the findings of a current appeal to COL's decision.
- 14. Munda and Gizo subprojects are also awaiting SMEC's finalised designs before LARP's can be drafted. For Auki water supply, four new bore sites have been identified, and drilling was undertaken in this reporting period.
- 15. Following the termination of REAN-PCS because of repeated delays and non-performance, the contractor sought and gained an injunction and the Court ordered a 'stay' on the termination, which has still not been resolved. Works continue to be discussed for the Kongulai WTP whilst construction of the Honiara Water Supply Service Reservoir (Panatina, Tasahe, and Titige reservoirs) and Honiara Water Supply-Trunk Mains is ongoing, with PMU safeguards staff monitoring implementation.

# 2.2. Safeguards Implementation Arrangements

- 16. SW has a Project Management Unit (PMU) delivering the Project. Recently SW received confirmation from World Bank that the oversight of World Bank safeguard policies for UWSSSP has been transferred to the task team safeguards specialists. SW will no longer need to seek Regional Safeguard Advisor approval for safeguards instruments. This change made as a result PMU safeguard team's strong commitment to manage safeguard risk and to pro-actively organise training for contractors to improve the quality of their documentation.
- 17. At the beginning of the Project, the PMU recruited specialists to provide intermittent inputs to ensure compliance with development partner safeguards requirements including provision of support to the PMU and conduct of due diligence. The National Social Safeguard Consultant position has not been filled since the incumbent left last year and the role is vacant to date. **Table 1** provides an overview

on the engagement of the international specialists and the proportion of their time used to 30<sup>th</sup> June 2024.

- 18. The project's RF, approved in 2018, lays out the approach to complying with objectives of involuntary resettlement safeguards. Land acquisition is to be avoided where possible and involuntary settlement impacts minimised, or at least restored for the livelihoods of affected persons (APs). The RF in this context provides guidance on the assessment and mitigation of resettlement impacts, the preparation of land acquisition and resettlement plans (LARP) and/or due diligence reports (DDR), and the implementation and monitoring of compensation and income restoration measures for APs.
- 19. Based on the project RF, an initial LARP was finalised on 8<sup>th</sup> March 2019 for the six subprojects based in Honiara including:
  - Water reservoirs at (a) Tasahe, (b) Titinge Ridge, and (c) Panatina
  - Rehabilitation and building the new water treatment plant at Kongulai
  - Augmenting the trunk mains from (a) Kongulai to White River and Rove Trunk Main; (b) East Kola to Naha Trunk Main, and (c) Panatina SR to Burns Creek Trunk Main – to expand the existing network
  - Upgrades of sewer outfalls
  - Construction of additional sewage pump stations and refurbishment of King George VI and Point Cruz wastewater pump stations
  - Construction of a septage treatment facility to service the Greater Honiara area.
- 20. It was estimated that a total of 20,648m² of land would be impacted by the project. Of this land, 15,706m² would require negotiation of agreements with private landowners. SW's priority in all land negotiations is to pursue outright purchase of land, and only resort to lease arrangements when outright purchase negotiations are unsuccessful. The Kongulai WTP subproject required purchase of land for resettlement of 41 APs (eight families), as did Titinge Ridge reservoir site which has six APs (one family). The overall LARP has now been superseded by a number of LARPs prepared for each subproject.
- 21. A summary of the status of the various LARP and DDR can be found in **Table 5** under the Social Safeguards Monitoring Section 4.
- 22. The Honiara Watershed Management Project (HWMP) began in 2023. It will develop effective partnerships and build institutional, financial and technical capacity

to protect water catchments. An EARF and LARF, based on the documents prepared for the main project, have been separately prepared for the HWMP.

23. There has been ongoing review and updating of the Initial Environmental Examination (IEE) /Public Environmental Reports (PERs), Construction Environmental, and Social Management Plans (CESMPs) required for the UWSSSP projects within this reporting period. Details are provided in the next section.

#### 3. ENVIRONMENTAL MONITORING

# 3.1. Environmental Safeguard Documentation and Instruments

- 24. Progress has been made on the various IEE/PER and Development Consents (DCs) during this reporting period. All PERs required for UWSSSP Phase 1 have been completed and approved except the PER for Gizo water supply which is pending ongoing hydrogeological investigations at Mile 2, 3 and 6. The expected timeline for Gizo PER submission is by the end of Q4 2025.
- 25. The Noro Water Supply Project and Munda Water Supply Project DC applications were approved in the last reporting period. There were no written objections received from any individual or organisation in this reporting period. Contract has been awarded to CCB Envico Pty Ltd. Contractor is expected to mobilize on site in Q1 2025.
- 26. The Gizo water supply project IEE/PER revision and finalization is further delayed awaiting approval for more hydrogeological investigations at Mile 6 lake and surface water sources.
- 27. UWSSSP Phase 2 PERs, Honiara Water Main Replacement and Honiara Water Pipeline Expansion PERs, have been reviewed. Comments from donors have been included in the final draft in this reporting period. Draft (V2) of the PER was submitted to ADB on 23<sup>rd</sup> September 2024. External specialists reviewed and updated the PERs in this reporting period. The PER is expected to be finalized and submitted to WB for approval in Q1 2025.
- 28. Auki Water Network Expansion subproject proposal application (PA) has been received, finalized and submitted to MECDM on 13<sup>th</sup> June 2024. MECDM will review the PA to determine the type of instrument to be prepared for the Auki subproject. No response received from MECDM in this reporting period. A response from MECDM is expected to be received in the next reporting period.
- 29. The preparation, review and approval status of IEE/PERs is summarised in **Table 2** below.

# 3.2. Construction environmental and social management plans (CESMPs)

- 30. All CESMPs for current Phase 1 projects have been approved by SW.
- 31. Review and updating of the Noro CESMP based on ADB's comments was completed in this reporting period. SW have approved the final draft of the CESMP in Q4 2024. The final draft of the CESMP will be submitted to WB in Q1 2025 for final review and approval.

### 3.3. Environmental Monitoring and Inspections

32. There were routine weekly site visits to Panatina, Titige and Tasahe reservoir sites, White River trunk main site, Kukum, and the Ranadi-Goodwood sewer and outfall construction site during this reporting period. Works undertaken by the contractors were mainly associated with trenching and excavations works, and pipe laying. In situ reinforced concrete (RC) works, form works and concrete pouring for tank walls continued at Panatina, Tasahe and Titige reservoirs in this reporting period.

Two environmental inspections were carried out by SWs National Environmental Office in Q3 2024 for the reservoir and trunk main projects. The key issue raised and addressed by the contractor was effectively managing the traffic. PEP were again reminded to also comply with all requirements of the CESMP and on proper dewatering of ground water into existing drains.

33. An environmental audit of all project sites was carried out by SW's National Environmental Officer and the International Environmental Safeguard Specialist in Q4 for the reservoir and trunk main projects. Identified issues and non-compliances were provided to PEP via site instructions and site inspection reports.

In addition, a joint site inspections with WB/ADB safeguard specialists were conducted on 11<sup>th</sup> December 2024 at the HNWS reservoir sites. The site inspection report, which include corrective actions and recommendations, was issued to the contractor for rectification of identified issues. To date, some of the corrective actions and recommendations are still outstanding and yet to be closed. Summaries of corrective actions and recommendations for each current subprojects in this reporting period are provided in Appendix 1.

- 34. Implementation of CESMP at the reservoir sites have shown significant improvement in this reporting period. However, there were several issues observed and recorded at the trunk main construction sites. Improved implementation of CESMP, TMP and SMP is required of PEP. Deficiencies included:
  - No traffic signage's installed when undertaking works along roadsides;
  - Absence of safety barricades and signage;
  - Poor waste management practices;
  - Lack of reporting and documentation of incidents and grievances;
  - The need to improve erosion and sediment control; and,
  - Non-compliance with PPE requirements.

35. There were two (2) stop work notices (NTC 148 and 157) issued by relevant SW PM for trunk mains during this reporting period. The stop work NTCs was related to non-compliance with CESMP, SMP and TMP requirements on construction works along the Kongulai to White river section, and night works at East Kola to Kukum Section. However, SW PMU have assisted the contractor to rectify all non-compliances on site while they continue to undertake their construction activities.

### 3.4. Due Diligence for UWSSSP Phase 2

- 36. SMEC was appointed to undertake the detailed engineering design for UWSSSP Phase 2 subprojects. The following subprojects are financed under the UWSSSP (Phase 2):
  - Auki Water Network Expansion
  - Honiara Water Pipeline Rehabilitation and Expansion, and
  - Honiara Water Network Expansion
- 37. Review and updating of Phase 2 PER is ongoing in this reporting period. The final draft of the Honiara Water Pipeline Rehabilitation PER has been finalized and submitted to ADB/WB for review and approval on 11th June 2024. Draft (V2) of the PER was submitted to ADB on 23<sup>rd</sup> September 2024. External specialists reviewed and updated the PER in this reporting period. The PER is expected to be finalized and submitted to WB for approval in Q1 2025.
  - 38. The following Phase 2 projects require development consents from MECDM (see Table 3).

### 3.5 Workers' Health and safety

- 39. There were several health and safety issues recorded in this reporting period. The key H&S issues observed were:
  - A small number of workers not complying with PPE requirements;
  - JSA were not reviewed and updated;
  - The potential for a metal object to strike the power line from the scaffolding in place at the batching plant at Titige reservoir project site. Refer to Appendix 3 for close out report;
  - A working at height breach was observed at the Tasahe reservoir sites. The subcontractor staff were working without safety harness at an altitude of >2m. The non-compliance was resolved immediately on site by SW management and the contractor. Similar breaches were identified at Panatina reservoir site during the joint site visit, and PEP was instructed to undertake appropriate measures to improve scaffolding at all reservoir sites.
  - Poor scaffolding standard and safety at all reservoir project site. There was evidence of no regular safety check system.
- 40. The issues were communicated to PEP via site instructions and inspection reports. The importance of complying with PPE and TMP requirements in the approved CESMPs was highlighted to the contractor when doing the routine weekly site visits.

### 3.6 Training

- 41. In October, SW facilitated a half-day refresher workshop with contractor safeguard officers. The workshop was also attended by SW project engineers and CLO. The environmental audit outcomes were discussed with PEP health and safety officers with an emphasis on:
  - Record keeping and documentation of incidences and grievances;
  - Signage;
  - Calibration of monitoring instruments; and,
  - Spill control.

### 4. SOCIAL SAFEGUARDS MONITORING

### 4.1. Status of Implementation of LARPs

- 45. The social safeguards team has continued to provide oversight on the implementation of four CESMPs of subprojects that are being constructed simultaneously in Honiara as well as undertaking ongoing negotiations with land owners to complete the LARPs for subprojects that are still undergoing final detailed designs. Part of the work also includes the ongoing monitoring of LARPs that have been fully implemented. The only subproject which has been completed and is now in operation in the Auki Water Supply Improvement project. The oversight work on the CESMPs is performed through conducting visits to construction sites, reviewing contractor's monthly monitoring reports, supporting contractors in their consultation requirements and assisting in resolution of grievances.
- 46. During the last two quarters the social safeguards time was divided between ongoing negotiations with land owners to complete the subproject LARPs for subprojects that are still undergoing final detailed designs, and providing oversight on the implementation of four CESMPs of subprojects that are being constructed simultaneously in Honiara.
- 47. The summary of the status of the different subproject LARPs for both Phase 1 and Phase 2 is shown below in **Table 5** with some activities continuing from the previous reporting period. Under Phase 1 of UWSSSP, 13 LARPS are required. Six LARPs have been completed and received a No Objection (NO) from ADB/WB, while five of them are still being worked on. For the second phase of the project, it is likely that due diligence reports will be required for the water and wastewater pipeline rehabilitation projects, since construction works will be within existing easements. The water supply expansion projects, on the other hand, are likely to trigger the involuntary resettlement policy of ADB/WB, as new land may need to be acquired if trunk mains are installed within private land, and/or if works will cause economic displacement. The detailed designs for the Honiara water supply rehabilitation and expansion showing the pipeline alignment have now been completed and a DDR will be drafted in the next reporting period.

### 4.2 Honiara Water Supply (HNWS)

- 48. The three (3) LARPs for the Honiara Water Supply Project which have already been approved by ADB/WB are: (i) Kongulai WTP; (ii) Water Mains Upgrading; and (iii) Augmenting Reservoir Capacity (Panatina, Tasahe, and Titinge reservoirs). All land required for the project, both government and privately owned, has been acquired. Implementation of the relevant LARPs has been completed except for two outstanding resettlement payments to two APs.
- 49. **HNWS Trunk Mains LARP**: There are only two resettlement payments that are yet to be completed under the HNWS Trunk Mains LARP as follows:
- <u>SDA Church</u>: There is one outstanding payment for SDA Church to complete the total payment for the easement access (area of 84.4 m<sup>2</sup>). Eighty percent (SBD 81,024) of the payment has been paid with the remaining 20% to be paid after the survey and easement instruments have been executed, which are still progressing. This is for water supply trunk main East Kolaridge to Kukum section. Works on this section have commenced. The survey was carried out in November 2022. Alignment was reviewed in Q4 2024 due to site constraints (existing concrete slab and vegetation located within proposed alignment).
- Mr. K: During the development of the HNWS Trunk Mains LARP, the alignment of the pipeline within Mr K's land at White River area, had not been finalised. At that time, an agreement was made with, Mr. K in December 2020 that after construction of the new pipeline, a survey for the subdivision for easement of approximately 2.5 m from the pipe centreline within his land will be performed and associated payments made to him immediately after. The cost will be calculated based on the rates used in the Sales Agreement in January 2020 which was \$217.00 per SQM. The survey for the subdivision for easement is yet to be carried out.
- 50. **Kongulai WTP LARP**: The Kongulai WTP LARP has been fully implemented. Works started on site including the setting up of a site office, workers' rest bays and sanitation facilities. Excavation works also commenced after a stop work notice was lifted by SW following the implementation of sedimentation control works on site by the contractor. However, progress was very slow, and there were so many Notices to the Contractor (NTCs), the contractor was eventually offered an extension of time (with conditions), but refused the conditions: so the contract is effectively terminated by SW. Work ceased on site on 13<sup>th</sup> December 2023, pending legal action to resolve the matter. Discussions around this are on-going.
- 51. **Community Advisory Committee (CAC)** (Kongulai, White River, Tasahe): The first CAC was established on 1 February 2023 CACs for other Honiara subprojects (including trunk mains, reservoirs and wastewater) are yet to be established, and are posing some difficulties, because they are commercial areas, and the businesses and working people living there are not a cohesive community. No other CACs have yet been formed, but Titinge should be next. No CAC was established during this reporting period.
- 52. **HNWS Reservoirs:** The LARP for HNWS reservoirs (Panatina, Titinge and Tasahe Reservoirs) has been completed and fully implemented. There are no resettlement issues relating to the sites during the reporting period. Consultations with communities were held before construction began and works are underway.

## 4.3 Honiara Wastewater Project (HNWW) LARP

- 53. The Honiara wastewater subproject is separated into 2 sections: The Eastern Section which is defined by the proposed network starting at Point Cruz and ending at NRH (also referred to as NRH section) and the Western Section which runs from the Bahai Area up to Ranadi/King George area. The LARPs for the two sections were drafted by SUEZ and reviewed by SW, while the detailed designs were being finalised in 2022. Negotiations with land title holders for easement access and land acquisition continued during the reporting period, though no new MOU was signed during this period. The SW PMU safeguards team have been working to properly complete the two LARPs, furnishing them with the relevant signed MOUs with the respective land title holders/APs as identified in those LARPs. The status of the negotiations for MoUs with the identified APs for both the Western and the Eastern HNWW are discussed in Table 6. To achieve consistencies across the LARPs, all negotiations and agreements have been or will be, captured in MOUs between SW and the respective APs or land title holders.
- 54. In the Eastern wastewater system, the Ranadi to Goodwood Outfall section had a separate LARP developed specifically ahead of the rest of the eastern wastewater system, due to the urgency to construct that section in time for the Pacific Games in November 2023. The Goodwood LARP received an all clear from the development partners on 6th September 2022 and construction was supposed to take 10 months. However, Pacific Engineering Project Limited (PEP) who was awarded the contract to construct this section of the infrastructure was so late starting, the system was not finished in time for the Pacific Games. The pump station and outfall at Goodwood Timbers has been removed from the scope, as they are no longer required to serve the Pacific Games facilities, and in any case, were to be abandoned after the Games. The project will now end at the last manhole at Goodwood Timbers, where it will interface with the permanent Ranadi Ocean Outfall. Works are continuing with nearly all sewer pipe section completed by November 2024, but construction of 16 manholes still to be completed. The likely completion date will be around mid-2025
- 55. **HNWW Eastern**: On 6th September 2022, the LARP was cleared by ADB/WB. Pacific Engineering Project Ltd (PEP) was awarded a contract and construction started (though late) in Q2 of 2023.
- 56. There are two main concerns for the HNWW Eastern LARP:
  - KCM Limited: Although the owner of the proposed site for the Naha wastewater pumping station located along the Kukum Highway, did not object to SW constructing the pump station within his land (320m²), he could not agree to any of the numerous offers that SW has proposed. SW therefore asked the Ministry of Lands (MOL) for resumption of the land and is awaiting progress from MOL. SW will follow-up with MOL in Q1-Q2 2025.
  - Tropical Helicopters (TH): According to the designs done by Suez, the best option for the proposed siting of the Ranadi PS is within the road reserve in front of the Silent World Compound with an overflow pipe (for emergency purposes only) designed to go through the western boundary fence of the compound owned by Tropical Helicopter Company. Despite

constant follow-up, TH has remained unresponsive to all communications. SW therefore decided to liaise with Douglas Logistics (DL), who share boundary the same boundary with TH hoping they would be happy to cooperate with SW. A letter was sent to DL towards the end of Q3 2023 regarding the SW proposal. SW has yet to receive any feedback from DL though in a brief meeting held with them in Q2 2023, they sounded eager to have further discussions with SW. SW also assessed the possibility of applying to the CoL for resumption. This will be followed up in Q1/Q2 2025. The last date to resolve this is the end of June 2025. (Outside the reporting period, in February 2025, SW managed to get a response from Tropic Helicopters through personal networks).

- 57. **HNWW Western**: In the LARP for HNWW Western section, there are no concerns in relation to acquiring land for easement access or sublease arrangements. The status of negotiations with the respective land title owners are presented in Table 6.
  - Solomon Islands Ports Authority (SIPA): SW will require pipelines and a PS to be installed within the land owned by SIPA. SW engaged the services of a valuer to value all the lands required by SW for pipe installation and the PS within SIPA land SW has put together a draft MOU with offers inserted based on the valuation, but has yet to receive a response from SIPA. SW will follow this up in Q1/Q2 2025.
  - United Church of Solomon Islands (UCSI): A draft MoU containing an offer for easement payment based on the value that UCSI have requested, was submitted to UCSI who say that they are satisfied with the content of the MOU. MOU was signed on 28<sup>th</sup> June 2024.

**Seafront Trustees:** SW has approved an increased offer as requested by the seafront trustees for the outfall sections (both eastern and western). However, the legality of ownership of the seafront is currently still being contested in court by the Commissioner of Land (COL). Feedback was received from CoL on 7<sup>th</sup> June 2024 saying the Registrar of Titles is to deregister the land. Whether it is customary land, depends on an assessment of any claims over the area. Therefore, SW is awaiting the determination of the court and CoL before proceeding further.

# 4.4 Provincial water supplies

- 58. **Tulagi Water Supply**: All resettlement activities have been completed. The APs have received their payments and there are no other outstanding payments or pending MoUs. SW proposed to scale back the scheme due to finance considerations, and the project is currently on hold.
- 59. **Noro Water Supply:** The Noro LARP was completed in September and submitted to WB/ADB for approval on 27<sup>th</sup> September. An MOU was signed on 29<sup>th</sup> September with the respective trustees for the lands where the Noro Water Supply upgrade works will take place. The LARP was updated to include the signed MOU, and was submitted to WB on 23<sup>rd</sup> December 2024 for approval and no objection.

- 60. The Commissioner of Lands (COL), appointed an acquisition officer (AO) to facilitate the proper processes to have the 3 parcels of Ziata land legally registered under the rightful landowners. This will enable SW to formally establish a lease agreement with them.
- After the 11 appeals against the AO's (CoL) determination were lodged in December 2023, SW started to re-engage with the 3 land owner groups of and and who previously provided support letters to the project but were not in the newly determined land owners. Individual consultation was conducted with the group in late March 2024. Further individual meetings and all landowner's stakeholder engagement and forums were planned before the actual project construction. Representatives of the LOs were flown to Honiara by SW, who had fruitful discussions and arranged for the group to meet with the newly elected Prime Minister, who listened to their views. While the details of the appeals are not yet known, support for the project remains high, and the breakaway sub-group seems to be drifting back to the main group of landowners which may simplify the negotiations.
- 62. Possession of the site was given as of 15 July 2024 with the Contractor to start works in January 2025. Meanwhile SW awaits the outcome of the appeal before finalizing the land agreement.
- Munda Water Supply: Suez developed a draft LARP and the majority of the 63. design for Munda subproject in 2022, after consultations were conducted with customary and registered land owners who all supported the project, citing the need for water in Munda, but were unable to complete the hydrogeological testing required to complete the design. Owners of the customary lands also provided support/consent letters to SW, to allow SW access to the land to carry out pipeline works. The Munda water supply design includes a reservoir, as part of the Munda system. A site at Polovesu has been identified for this purpose 'owned' by the family who are also residing there. Polovesu, though it is customary, has about four generations of the family living on it: this family is part of the Kazakuru clan, but is recognised by them, as having primary rights in the land. The land has not yet been registered and is therefore considered customary land. The family has been consulted on numerous occasions, and they have maintained their support for the project and for the siting of the reservoir within the family land. To ensure that legal instruments are established to allow SW to have a proper lease agreement with the owners for the proposed tank site, the COL will have to initiate the land acquisition process according to the Land and Titles Act similar to the one that is currently happening for Noro. SW commissioned SMEC to undertake more hydrogeological testing on customary lands and to incorporate the findings in the final design, before providing instructions to the COL for the acquisition process.
- 64. SW developed a draft MOU with the family whom they met in Honiara on 21<sup>st</sup> November 2022. There has not yet been any response to SW regarding the draft MOU.
- 65. The maps of the proposed pipeline routes in Munda have been provided in the draft LARP but there is still the need to verify that the pipelines will not encroach into private properties. Suez stated that the proposed pipelines will follow the roads and

had intended to follow up with MID to ascertain whether the roads in Munda have been gazetted. It has yet to be determined if MID or the provincial government own the roads, particularly within the Lambete area. The roads within Dunde area are customary, and there has already been a letter of support and consent from the community's chiefs to have the pipeline installed along the road. The proposed airport bore, north of the runway is within the land owned by the commissioner and therefore SW is going to prepare an MOU with the COL to allow access to rehabilitate and operate the borehole. At this stage no tests have been performed on the borehole to determine its state and yield. In case it is discovered to not be adequate, SW will have to look for an alternative bore site, likely to be in the Dunde area and situated on customary land. With SW priorities focused on Honiara infrastructure and other areas, progress on the Munda LARP has been slow.

- 66. **Gizo Water Supply**: Detailed design works on the pipelines were completed by SMEC. The hydrogeological survey of three boreholes owned by the Western Provincial Government, was completed at the end of 2022 with results that show the yield is insufficient and that boreholes need to be re-tested and additional sources found. SW conducted another bore investigation. The preparation of the LARP and identification of APs for the complete network was undertaken by Suez in 2022 but not completed. However, it was established with Suez during the designing of the system, that all pipe routes must follow the road reserves. During the reporting period, the progress of the Gizo LARP remained unchanged as noted in Table 6. This LARP is pending the final results of the re-testing of the boreholes. SW does not want to pursue any negotiations with APs until source water issues are resolved. However, this is a priority project likely to be part funded by the Government of Australia's Department of Foreign Affairs and Trade (DFAT).
- 67. The list of LARPs and their approval status is shown on Table 5 (above), while the following Table 6 below, describes the progress of negotiations with land owners:

#### 4.5 Outstanding Resettlement Activities

- 68. The Safeguards Team continues to monitor the construction works, but all current resettlement provisions have been completed for Honiara subprojects. Monitoring of site works is normally done in coordination with the National Social Safeguards Specialist, (a position which is currently being recruited for) and National Environment Safeguards Specialist in SW PMU. The contractors also submit monthly safeguards monitoring reports, which are reviewed by the PMU staff, who provide feedback through a 'Notice to Contractor' (NTC) system. There are currently four CESMPs being monitored: the Honiara Water Supply Trunk Mains, the Honiara Water Supply Reservoir subproject, Honiara Wastewater Ranadi to Goodwood section and the Kongulai Water Treatment Plant subproject.
- 69. There will be future resettlement and compensation requirements for the Eastern and Western HNWW subprojects and the provincial water supply projects including Munda, Gizo and Noro for which LARPs are still progressing. During the reporting period, efforts have been made on consultations and negotiations with APs relating to the ongoing LARPs.

**Matters of significant importance:** There are no matters of significant importance raised in the last six months, apart from the usual construction delays.

#### 5. COMPLIANCE WITH PROJECT SAFEGUARDS COVENANTS

70. The project is addressing project related covenants of ADB. Appendix 2: Compliance with safeguard-related project covenants provides a summary of the compliance with the covenants included in the ADB and SIG project agreement.

#### 6. PUBLIC CONSULTATION, DISCLOSURE, CAPACITY BUILDING

71. Public consultations have been held to comply with plans in the IEE, the LARP and the Project's Stakeholder Engagement Plan (SEP). The consultations are guided by WB and ADB best practice as outlined in their manuals and guidance notes.<sup>4</sup>

#### 6.1. Public Consultation Activities

72. Consultations, information disclosure and awareness raising activities have been ongoing during the reporting period. A summary of the consultations conducted within the reporting period are in Table 7. With construction works now proceeding, the SW PMU continues to provide support and oversight of the contractors' consultation requirements to ensure that the APs and the public are properly informed in adequate time before work proceeds and in the event that work completion is delayed. All consultation materials drafted by the contractor go through SW management for clearance before they are used to ensure messaging is correct. The PMU CLO has been instrumental in facilitating this requirement.

#### 6.2. Planned Consultation Activities for January-June 2025

- 73. There will be on-going consultations with Honiara and provincial communities and particularly with landowners where land issues are likely to be obstacles to implementation of both Honiara and provincial water supply plans. As outlined in the updated Stakeholder Engagement Plan, Community Advisory Committees, (CACs) are planned for six areas in Honiara, and one in each province. Work will continue to assist contractors to establish the CACs for Honiara sites, in order to facility participation of community members during construction. With the Honiara Water Supply under construction and the Goodwood section of HNWW, SW will ensure that all the CACs for Honiara are established and effectively implemented. SW will also be providing oversight on consultations that the contractor will be doing. Given the construction delays and probable contract termination for the Kongulai WTP, it will remain critically important to involve the existing CAC and keep the community well informed about the issues and delays in implementation.
- 74. The detailed designs for the Phase 2 subprojects are for the most part, completed, and therefore consultations with Honiara and provincial communities will be reported in the January to June reporting period.

#### 6.3. Capacity Building and Training

- 75. The International Environmental and Social Safeguards specialists, and WASH advisor, have continued to provide specialist inputs, and to mentor and support SW staff in preparation of safeguards documents. There have been discussions around using and updating the GAP monitoring framework between consultants, the SW safeguards team, and ADB advisors. More training on the GRM will be required once the revised process and SOPs are completed in Q1 2025.
- 76. As reported in the Environment Safeguards section, (3.6) SW provided a refresher training to contractors safeguard officers and SW project engineers. SW International Environmental Specialist facilitated a half-day workshop to discuss the outcomes of the environmental audits with PEP H&S officer. The primary focus of the workshop was on effective implementation of CESMPs on the construction sites with more emphasis on: Record keeping and documentation of incidences and grievances; Signage; Calibration of monitoring instruments and Spill control.

#### 7. GRIEVANCE REDRESS MECHANISM (GRM)

- 77. SW established a GRM to deal with grievances from the general public and affected persons in relation to all SW managed projects and covering all stages of SW's projects' cycle. The GRM covers both social and environmental grievances and care was been taken to ensure confidentiality for those making complaints. The focal point of contact for the GRM is the national Social Safeguards Consultant and the Community Liaison Offer (CLO). This information is continuously be relayed to the customer service front should anyone with concerns and questions approach SW regarding the project: complaints and grievances are referred to the focal point appropriately. The existence of this GRM has been communicated to communities during project consultation with the names and contacts of the focal points also made available to the communities during consultations.
- 78. The GRM is a three-stage process (currently under review) which allows for appeals at each stage: complaints are forwarded to the Project Manager who tries to solve the complaint. If a solution cannot be reached the complaint is referred upwards first to the Chief Executive Officer of SW and then, if no resolution is found, to a Grievance Tribunal of three people: (i) a member of the Board of SW; (ii) the Permanent Secretary (or designate) of the Ministry of Mines, Energy and Rural Electrification; (iii) an independent member jointly selected by Chief Executive Officer of SW and Board Chairman. Within five working days of the Tribunal meeting a formal response is issued to the aggrieved party outlining the Tribunal's decision on the grievance.
- 79. The decision is final as far as the SW grievance process is concerned but if this is still not accepted the complainant has the option of taking the complaint to the Solomon Islands judicial system. Disclosure of the GRM process and awareness of how it works has been delivered through the many community consultations.
- 80. The Safeguards team initially assisted contractors to ensure that their GRM is included training for staff on how the process works, that they included SEAH in their CESMP to show how they would respond to any incidents, and that they require all employment contracts to have a signed Code of Conduct for employees. However, this process was assessed to be needing improvement (by the ADB/WB Mission), and the Safeguards and Gender team are currently revising the GRM for SW, especially to ensure that there is a separate confidential reporting channel for SEAH complaints. This will make use of local service providers to ensure victim/survivors of SEAH receive confidential support from qualified experts. This will put the victim's needs and wishes at the centre of the process. A draft of the revised GRM system will be available in Q1 2025, and will confirm roles and Standard Operating Procedures (SOPs), and update documents. Training will then be provided for engineers, project managers, CLOs, and contractors, to refresh their understanding and inform them about how the revised process will work.

#### 7.1. Gender Action Plan (GAP) Implementation

- 81. Basic monitoring of milestones, progress, and GRM complaints on gender related issues is ongoing with SW's communication team providing support remotely to the international social safeguards and gender consultant. The communication team has overall responsibility for gender issues within SW, assisted by the safeguards team.
- 82. There is ongoing monitoring to ensure all consultations include women participants and that resettlement agreements are providing compensation to both men and women. All trainings on WASH and hygiene awareness aim to include at least 50 % women. However, because SW's national social safeguards and gender consultant resigned last October and has not yet been replace, it is proving difficult to gather all the necessary data to fully report on progress. Efforts are being made by retrieve information on earlier training numbers, and other details to put together a full cumulative list of activities.
- 83. For the Additional Financing Agreement (2), the SW gender consultant, in consultation with the ADB Gender Officer, reviewed activities and targets in the GAP to make sure they are effective in measuring progress as well as being realistic and achievable in the next phase. In particular, the team will have tried to ensure that women in communities will have equal opportunities and will be protected from any adverse social impacts related to SW activities.
- ADB did not agree that the GAP monitoring template, could be amended to simplify results, (since because it is presented as one huge table, rather than a more conventional report, so the structure is not easy to either write or follow.) The matrix is a standard ADB tool used in all their projects and cannot be changed. The recruitment of the national safeguards/gender specialist is in progress but has not yet been completed, so we are still awaiting this appointment, and some activities are therefore pending (such as plans to improve data collection).

#### 8. SUMMARY AND CONCLUSIONS

85. During this reporting period the following outcomes have been achieved and challenges faced:

#### 86. Environmental safeguards:

- SW facilitated a half-day workshop for contractors 'safeguard officers and SW project engineers to discuss the outcomes of the environmental audits. The primary focus of the workshop was on effective implementation of CESMPs on the construction sites with more emphasis on: Record keeping and documentation of incidences and grievances; Signage; Calibration of monitoring instruments and Spill control.
- An environmental audit of all project sites in Q4 with SW International Environmental Specialist, including an initial site visit to Noro project site.

- One (1) joint audit with WB/ADB Specialists conducted at the Honiara Network Water Supply Service reservoirs- Panatina and SSS batching plants.
- SW have finalized the IEE/PER for UWSSSP Phase 2 Honiara Water Main Replacement Projects. Draft (V2) of the PER was submitted to ADB on 23<sup>rd</sup> September 2024. External specialists reviewed and updated the PERs in this reporting period. The PER is expected to be finalized and submitted to WB for approval in Q1 2025.
- PEP's Environmental Officer and Environmental and Social Specialist have both resigned in the previous reporting period. There is no formal response from PEP regarding their replacements in this reporting period. The two (2) positions are still vacant to date.

#### 87. Social safeguards and Gender:

- Areas of concern remain the same as in previous reports. There has been slow progress relating to land acquisition, which is a key reason for the delay in submission of some LARP documentation. Much of the land needed for utilities is government owned, but there are tracts of privately held land or customary land, that are yet to be acquired, and where consultations and negotiations are on-going. Getting agreements with some parties has proved very time consuming, not to say frustrating. Also there have been difficulties in acquiring necessary land for pipelines and pump stations in Honiara, as private owners are reluctant to sell or lease for the official valuation rates. Many of the HNWW and provincial water supply LARPS are awaiting the signing of MOUs to finalise agreements with landowners.
- Noro LARP was finalized and submitted to ADB/WB for review and approval on 27<sup>th</sup> September 2024. MOU with Ziata source landowners was reviewed by Attorney General and then signed on 29<sup>th</sup> September 2024 to allow contractor to commence work Ziata site. The LARP was updated to include the signed MOU, and was resubmitted to WB on 23<sup>rd</sup> December 2024 for approval and no objection.
- Completion of LARPs and submission/approval of development partners still
  outstanding for Munda and Gizo provincial water supplies; and HNWW NRS
  and Ranadi Sewer Works sub-projects. These will be the priority for the next
  reporting period. MoLHS is progressing with revised land tenure
  arrangements for SW's three operational sites in Noro, and this may impact on
  the proposed UWSSSP upgrade works, delaying the commencement date.
- The difficult grievances of the Kongulai community took a lot of time by the Safeguards team, but all were satisfactorily resolved, a major achievement.
- Catchment Protection: Historic disputes and conflicts with customary land owners in catchment areas continues for land issues and natural resources management. A constructive dialogue has to be continued and financially and

socially viable compensation packages determined for forthcoming land use zoning and subsequent restrictions.

 While the implementation team for Catchment Protection have made progress in engagement with stakeholders, lack of coordination and timely consultations remain weak and lead to difficulties in developing sustainable catchment management strategies.

# 8.1. Recommendations for Implementation and Corrective Actions

- Contractors need to improve in their implementation of their CESMPs.
- Implementation of some of the corrective actions is ongoing as construction works are still underway at Panatina, East Kola, Titige and Tasahe reservoir sites. The termination of the Kongulai WTP contract is still being discussed.
- Contractors and subcontractor staff compliance for PPE requirements needs to be improved. Non-compliance to PPE requirement was observed in all of the construction sites during routine weekly site visits.
- The resignation of the national Social Safeguards and Gender consultant left a hole in the team since October 2023. A replacement is in the process of being recruited, but needs approval from donors, which we trust will be speedily expedited. This is an urgent requirement, as our social monitoring and reporting is affected by lack of appropriate staff expertise.
- The difficult work in establishing and operating Community Advisory Committees for HNWS needs to continue particularly for HNWS.
- During implementation of the WASH Hygiene Promotion Project, the WASH team need to identify any existing Water User Groups or WASH Committees so progress can be tracked.
- The international Social Safeguards and Gender consultant needs to meet with relevant SW staff to review data which is collected at time of water connection to households. There is a need to include more information, in order to monitor progress and social impacts of the project, (such as: age, literacy level, disability, income bands, and female headed households). A work plan is to be developed for implementation of surveys.
- Still need to set up Dropbox system for storage of gender documents relating to targets and indicators. Ensure all training materials, consultation reports, presentations, and other materials are provided to ADB/WB.
- Develop long-term plan for three surveys to help monitor the project impacts on women. These should take place in 2025, 2026, and 2028. A working

group consisting of the Gender specialist, WASH specialist, and M&E specialist to discuss with SW staff, the design of the proposed 2024 survey, in order to provide data to monitor the GAP and project indicators. A work plan yet to be developed for implementation of the survey(s).
